

Notification of the Industrial Estate Authority of Thailand

No. 63/2551

Re: Forms of Applications, Certificates, Reports and Letters of Certification for Application for Privileges

Whereas, the Notification of the Board of Directors of the Industrial Estate Authority of Thailand Re: Rules, Procedures and Conditions for Exemption from Special Fees under the Law on Investment Promotion, Import Duty, Value Added Tax and Excise Tax on Machinery, Equipment, Tools and Supplies, and Raw Materials, including Parts thereof which are Essential for Production of Goods or for Commercial Purpose, dated June 10, 2008, and the Notification of the Board of Directors of the Industrial Estate Authority of Thailand Re: Rules, Procedures and Forms of Permission to Bring Materials in the IEAT Free Zone out of the IEAT Free Zone, dated June 10, 2008, require the IEAT to prescribe forms of applications, certificates, reports and letters of certification pursuant to the rules as specified herein.

The Industrial Estate Authority of Thailand hereby prescribes forms of applications, certificates, reports and letters of certification for application for privileges under the aforesaid Notifications, as follows:

Clause 1 Forms of applications, certificates, reports and letters of certification under the Notification of the Board of Directors of the Industrial Estate Authority of Thailand Re: Rules, Procedures and Conditions for Exemption from Special Fees under the Law on Investment Promotion, Import Duty, Value Added Tax and Excise Tax on Machinery, Equipment, Tools and Supplies, and Raw Materials, including Parts thereof which are Essential for Production of Goods or for Commercial Purpose, dated June 10, 2008, shall use the forms attached hereto, as follows:

(1) Form IEAT-I-05 shall be used for application for approval of exemption from tax and duty on (imported) machinery and raw materials.

(2) Form IEAT-I-06 shall be used for application for approval of tax and duty exemption or refund on (imported) machinery and raw materials.

(3) Form IEAT-I-05, 06 R shall be used for report on materials under Section 48 (1) of the Industrial Estate Authority of Thailand Act B.E. 2522 (1979), as amended by the Industrial Estate Authority of Thailand Act (No. 4) B.E. 2550 (2007), that are brought into the IEAT Free Zone.

(4) Form IEAT-I-03 shall be used for application for issuance of certificate of bringing materials or raw materials into the IEAT Free Zone for export, so that such materials are not subject to the law on standard or quality control or seals or signs with respect to such materials.

(5) Form IEAT-I-04 shall be used for application for certificate of bringing materials or raw materials into the IEAT Free Zone for export, so that such materials are not subject to the law on standard or quality control or seals or signs with respect to such materials.

(6) Form IEAT-I-04 R shall be used for report on materials or raw materials brought into the IEAT Free Zone for export in the event that such materials are not subject to the law on standard or quality control or seals or signs with respect to such materials.

(7) Application forms under (1) and (2) may be used *mutatis mutandis* for the application for approval of tax and duty exemption or refund on raw materials which are materials under Section 48 (2) of the Industrial Estate Authority of Thailand Act B.E. 2522 (1979), as amended by the Industrial Estate Authority of Thailand Act (No. 4) B.E. 2550 (2007).

Clause 2 Applications, certificates, reports and letters of certification under the Notification of the Board of Directors of the Industrial Estate Authority of Thailand Re: Rules, Procedures and Forms of Permission to Bring Materials in the IEAT Free Zone out of the IEAT Free Zone, dated June 10, 2008, shall use the forms attached hereto, as follows:

(1) Form IEAT-E-01 shall be used for application for permission to bring materials out of the IEAT Free Zone under Section 55 of the Industrial Estate Authority of Thailand Act B.E. 2522 (1979).

(2) Form IEAT-E-02 shall be used for application for letter of certification for bringing materials in the IEAT Free Zone out of the IEAT Free Zone under Section 55 of the Industrial Estate Authority of Thailand Act B.E. 2522 (1979).

(3) Form IEAT-E-02 R shall be used for report on materials in the IEAT Free Zone that are brought out of the IEAT Free Zone.

(4) Form IEAT-E-02-1 R shall be used for report on materials in the IEAT Free Zone that are brought out of the IEAT Free Zone for any other purposes on a temporary basis.

This Notification shall come into effect forthwith.
